ARTISAN MARKET INFORMATION:

- The Wild Chicken Artisan Market will be held **Saturday, March 20th, 2021 from (9am-5pm)**. The Artisan Market showcases the handmade/homemade goods and wares of local artists and crafters. In an effort to maintain the highest quality of locally hand-crafted products, bought-and-resold items are not permitted.*
- **All vendors are required to be set up the entire time the market is open (9am-5pm)**. Carnegie Center for the Arts has a bathroom. Vendors will be responsible for bringing their own tent (not bigger than a 10x10), tables, chairs, and 50-ft extension cords (if power is needed).
- **Due to the COVID-19** Pandemic vendors will be spaced out 6-feet between each vendor.
- **Due to the COVID-19** Pandemic this event can be canceled at any time due to Government (Local, State, Federal) mandates or if it is deemed unsafe by the Wild Chicken Festival or Wild Chicken Festival Artisan Market Committee. There will be **NO refund**. There will be a voucher sent out with the amount you paid to go towards any Fitzgerald Ben Hill Arts Council Artisan Markets vendor fees.
- **Due to COVID-19** All Local, State, or Federal mandates will be adhered to during the event.

1. Vendor shall accept the space assigned. Locations will be assigned at the discretion of the Wild Chicken Festival Artisan Committee.
2. Each space is 10x10.
3. Vehicles must be removed from exhibit area by 8:30 am Saturday morning.
4. Vendor is solely responsible for collecting, reporting, and paying any required Georgia sales tax.
5. Please pick up a sales tax form when you register.
6. Vendor shall sell only items noted on applications.
7. NO REFUNDS will be made for any reason, cancellation, removal for cause, or act of God.
8. Checks returned from the bank shall void festival eligibility and be charged a \$35 charge.
9. All articles and displays must be in good taste. There shall be no reference to race, ethnic, sexual, or religious prejudice.
10. No obscene items shall be allowed.
11. Vendor is responsible for area cleanup after festival.
12. No part of your setup may extend beyond purchased space.
13. There is no rain date.
14. Vendors must not break down until the end of the festival (5:00pm). NO VEHICLES IN FESTIVAL AREA UNTIL 5pm
